Public Participation

Member of the public commented on planning application 20/03801/FUL, favouring anything to save the privacy of the existing properties on the south side of the road.

Cllr Berry proposed objecting to the application with revised plans as the conditions of the Parish Council supporting the application on 6 June 2020 had not been included, namely: 1. The development is moved further back on the plot. 2. The unadopted road is re-instated to its pre-development condition. Seconded Cllr Hassett, voting unanimous in favour.
